


Author Biographies

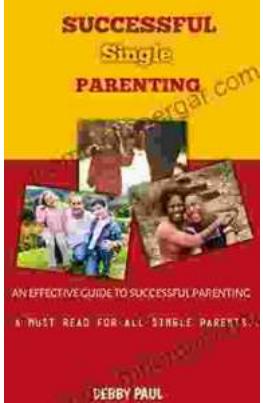
